## 1. 执行示例程序

### 示例按以下顺序执行:

- (1) 上电, 电源灯(LED1)点亮, LED2-LED4同时闪烁;
- (2) LED2-LED4 闪烁停止;
- (3) 用户可以使用可调电阻进行调节, "ANI4" 用于A/D转换功能(LED2-LED3 显示), "CMPIN" 用于CMP 功能(LED4 显示);
- (4) 用户可以使用按键, "RESET" 用于复位功能,程序重新开始执行;
- (5) 用户可以使用按键, "INTPO" 用于INPTO 中断, LED2-LED4 循环点亮直至全灭;

在使用示例前,请先明确MINICUBE2/EZ-CUBE硬件设置和与目标连接是否正确。

具体细节请参见MINICUBE2/EZ-CUBE用户手册。

并请检查MINICUBE2/EZ-CUBE是否使用了最新固件。

### 产品使用时的注意事项

本文对适用于单片机所有产品的"使用时的注意事项"进行说明。有关个别的使用时的注意事项请参照正文。此外,如果在记载上有与本手册的正文有差异之处,请以正文为准。

#### 1. 未使用的引脚的处理

【注意】将未使用的引脚按照正文的"未使用引脚的处理"进行处理。

CMOS产品的输入引脚的阻抗一般为高阻抗。如果在开路的状态下运行未使用的引脚,由于感应现象,外加LSI周围的噪声,在LSI内部产生穿透电流,有可能被误认为是输入信号而引起误动作。 未使用的引脚,请按照正文的"未使用引脚的处理"中的指示进行处理。

### 2. 通电时的处理

【注意】通电时产品处于不定状态。

通电时,LSI内部电路处于不确定状态,寄存器的设定和各引脚的状态不定。通过外部复位引脚对 产品进行复位时,从通电到复位有效之前的期间,不能保证引脚的状态。

同样,使用内部上电复位功能对产品进行复位时,从通电到达到复位产生的一定电压的期间,不能保证引脚的状态。

### 3. 禁止存取保留地址(保留区)

【注意】禁止存取保留地址(保留区)

在地址区域中,有被分配将来用作功能扩展的保留地址(保留区)。因为无法保证存取这些地址时的运行,所以不能对保留地址(保留区)进行存取。

### 4. 关于时钟

【注意】复位时,请在时钟稳定后解除复位。

在程序运行中切换时钟时,请在要切换成的时钟稳定之后进行。复位时,在通过使用外部振荡器(或者外部振荡电路)的时钟开始运行的系统中,必须在时钟充分稳定后解除复位。另外,在程序运行中,切换成使用外部振荡器(或者外部振荡电路)的时钟时,在要切换成的时钟充分稳定后再进行切换。

【注意】在变更不同型号的产品时,请对每一个产品型号进行系统评价测试。
