Join Us on the Road to Zero Waste

The Republic Services Wet/Dry Program puts you in compliance with California State Mandate AB 341

(http://www.calrecycle.ca.gov/Recycle/Commercial/FAQ.htm).

AB 341 is the Mandatory Commercial Recycling bill, which not only mandates that businesses recycle, but also sets a statewide goal for 75% disposal reduction by the year 2020. In San José, Republic Services already ensures that you are recycling over 70%—soon to be 80%—of materials. That's a great thing, and something to proudly tell your customers.

Request a 'We Recycle' Window Sticker

Ask your recycling coordinator for one of our great-looking window stickers that lets your customers know you care about the environment—then just be sure to place the proper waste in the proper waste container. That's it, Republic Services does everything else. With your continued help, we'll reach our short-term goal of keeping 80% of all collected waste out of the landfill, and our longer-term goal of sending nothing to the landfill.

Customer Spotlight:

Integrated Device Technology (IDT) IDT's Effort to Ramp-Up Recycling Pays Off

Integrated Device Technology (IDT) is a semiconductor solutions provider located in South San José. The company takes great pride in promoting sustainability initiatives across all aspects of its business operations—packaging, processing, and facilities.

Newby Tour a 'Real Eye Opener'

In April 2014, IDT's Environmental Health & Safety and Facilities group took advantage of the open invitation to tour the Newby Island Resource Recovery Park (NIRRP). The group, led by senior engineer Chhaya Gupta, wanted to see exactly what happened to the company's waste once it left their facility. According to Chhaya, "It was a real eye opener. The entire group was very impressed with the waste handling/sorting procedures. Obviously, Republic Services put a lot of effort and resources into implementing an efficient recycling program."

After the tour, Chhaya continued researching the Wet/Dry program. The videos on Republic's website (http://site.republicservices.com/site/santa-clara-ca/en/pages/san-jose-resources.aspx) inspired her to step-up the Wet/Dry program at IDT's San José facility. She also contacted Republic Services' representative to schedule a free waste audit. The audit showed how much waste the company was diverting from the landfill and Chhaya used that information as a baseline to implement changes and boost IDT's recycle and compost rate.

Mission Compost

Chhaya decided to more closely align her company's waste management program with Republic Services' Wet/Dry program. She used simple signs to explain exactly what waste items should go where. Almost overnight, IDT reduced food contamination in their blue Dry bins. According to Chhaya, "Our employees have been very well trained in recycling, but very few of us think about composting. I call our new program 'Mission Compost' and would recommend other businesses tailor Republic's program to meet their needs."

Which Bin Does It Go In?

If you said that coffee grounds and tea bags go in the Wet bin, you are correct! Generally speaking, food waste, food-stained papers, and other organic matter goes in the Wet bin to be composted, while other waste, recyclables, and glass go in the Dry bin.
