




TYPICAL CHARACTERISTICS (Ta = 25 °C)








DC CURRENT GAIN vs. COLLECTOR CURRENT




COLLECTOR CURRENT vs. COLLECTOR TO EMITTER VOLTAGE





V_{CE}-Collector to Emitter Voltage-V


COLLECTOR CURRENT vs. COLLECTOR TO EMITTER VOLTAGE
