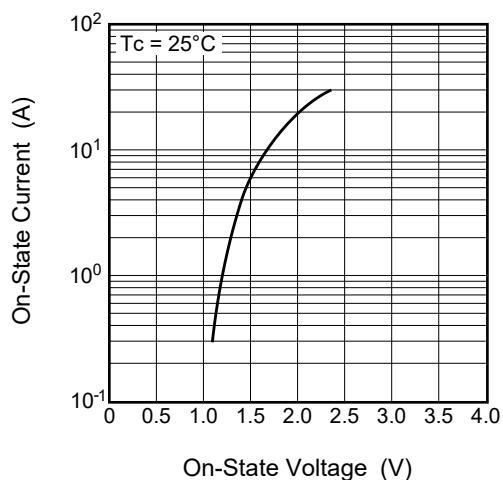

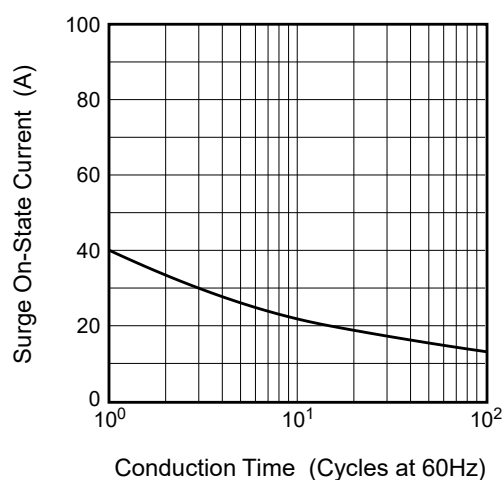

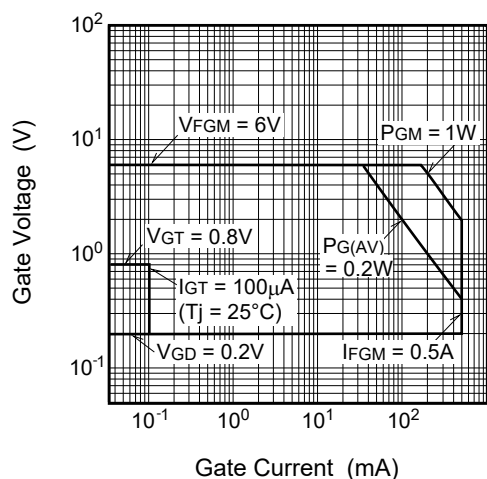
Maximum On-State Characteristics



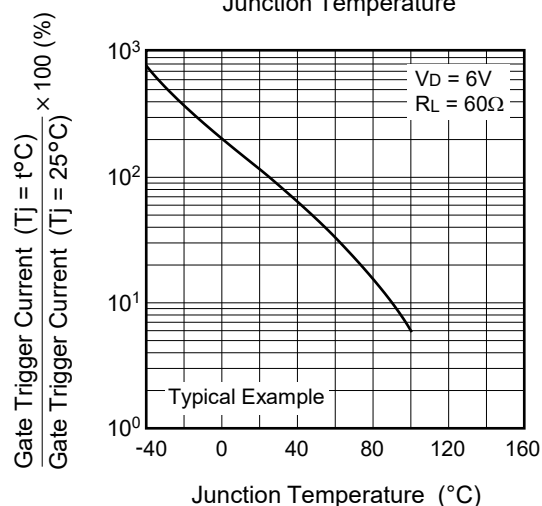
Rated Surge On-State Current



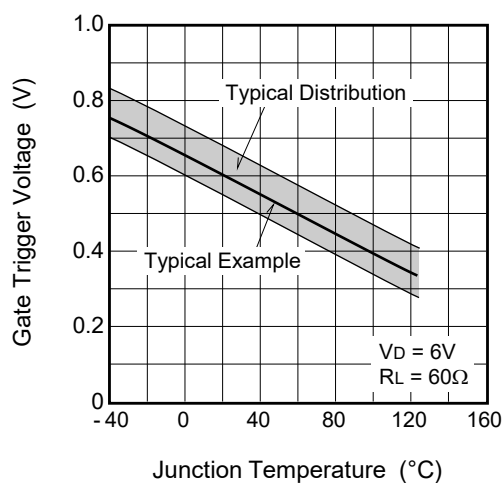

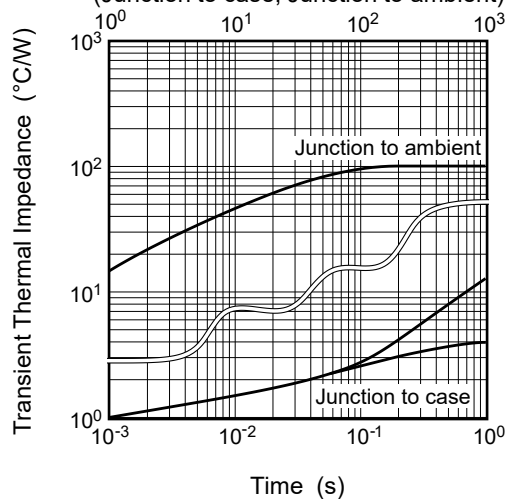
Gate Trigger Current vs. Junction Temperature

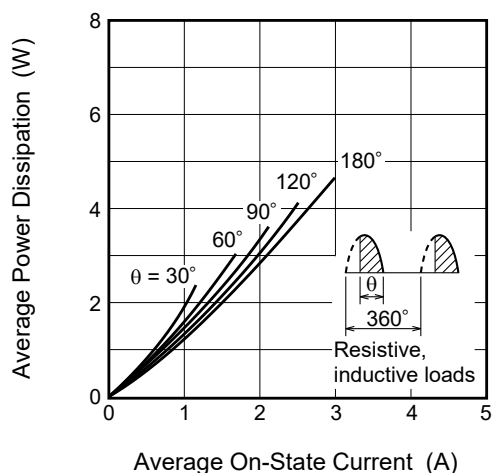
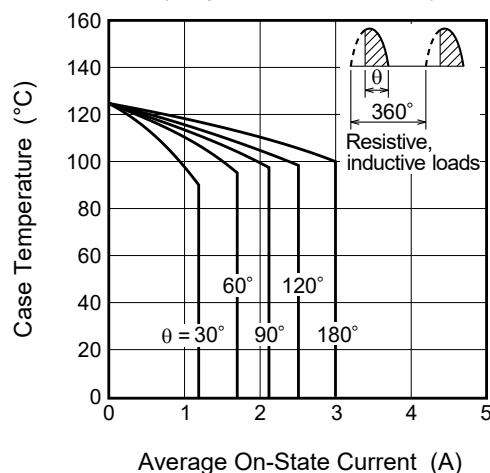
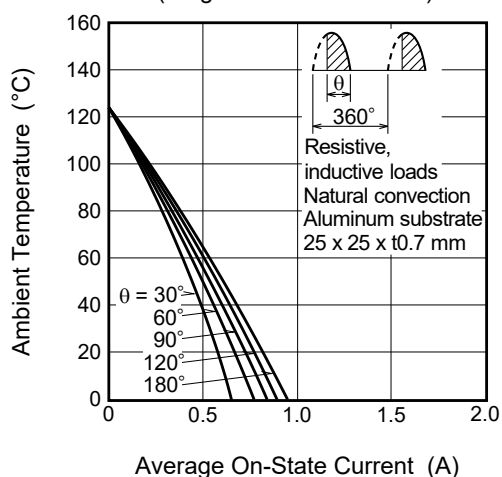
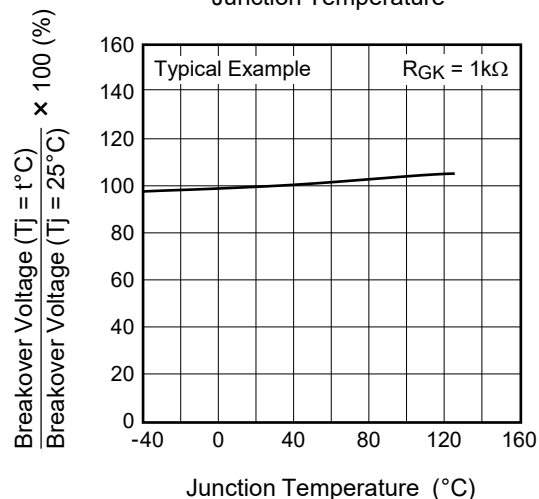
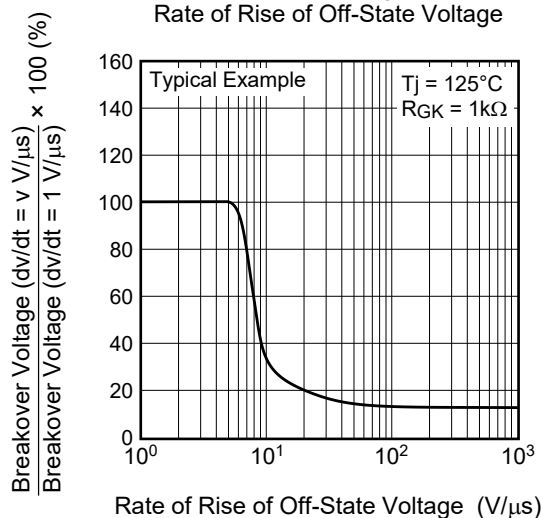
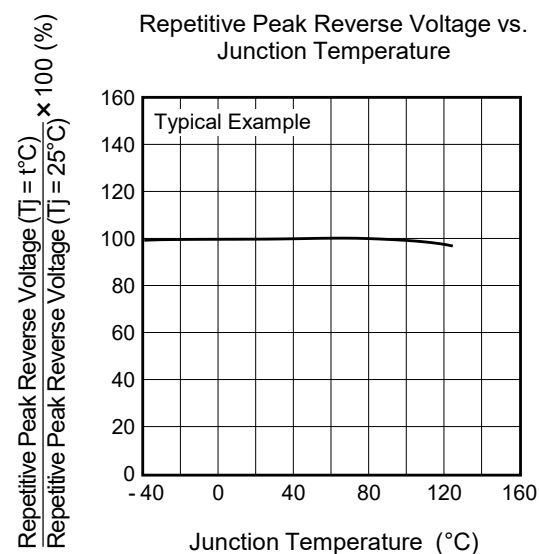


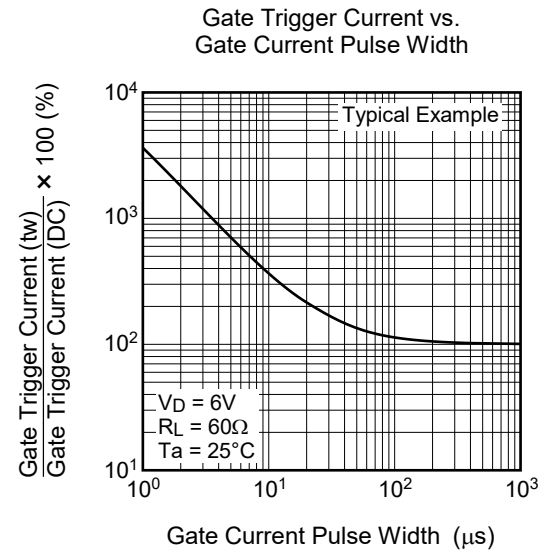
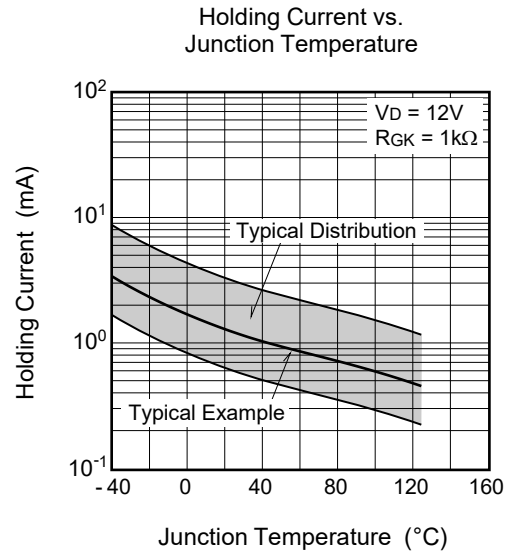
Gate Trigger Voltage vs. Junction Temperature



Maximum Transient Thermal Impedance Characteristics (Junction to case, Junction to ambient)

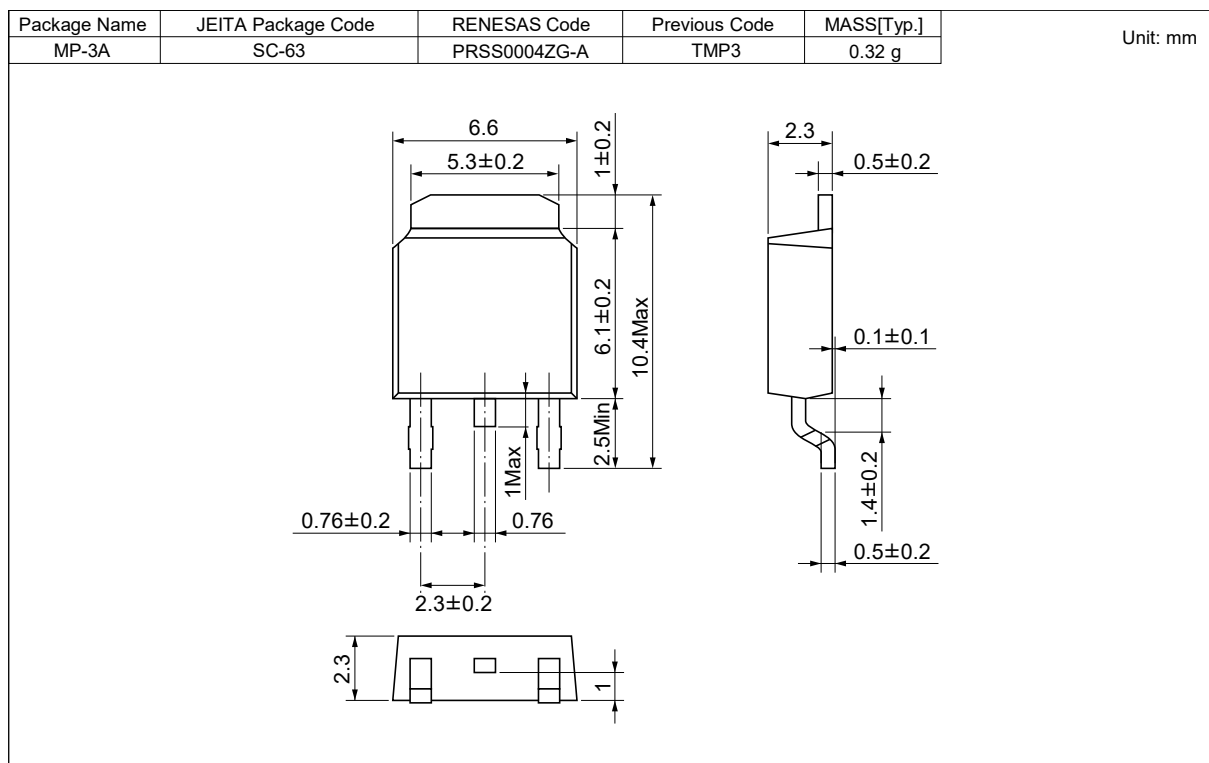
