### Description


The HD74LV1GW17A has dual buffer with schmitt-trigger input in a 6 pin package. Low voltage and high-speed operation is suitable for the battery powered products (e.g., notebook computers), and the low power consumption extends the battery life.

### Features

- The basic gate function is lined up as Renesas uni logic series.
- Supplied on emboss taping for high-speed automatic mounting.
- Supply voltage range : 1.65 to 5.5 V  
Operating temperature range : -40 to +85°C
- All inputs  $V_{IH}$  (Max.) = 5.5 V (@ $V_{CC}$  = 0 V to 5.5 V)  
All outputs  $V_O$  (Max.) = 5.5 V (@ $V_{CC}$  = 0 V)
- Output current  $\pm 6$  mA (@ $V_{CC}$  = 3.0 V to 3.6 V),  $\pm 12$  mA (@ $V_{CC}$  = 4.5 V to 5.5 V)
- All the logical input has hysteresis voltage for the slow transition.
